I believe as a Bikeability provider, Dudley Road Safety & Travel Awareness Team show exceptional qualities in all of the areas noted:

When I consider the delivery of high-quality scheme management and administration. I am in an ideal position as the newest member of the team, coming from a totally different professional background, to view the set up and comment. I noted very quickly that the organisation and provision of Bikeability is an integral part of 'The Offer' to all Dudley Schools, Community Groups and Individuals. Being truly inclusive in its ethos and delivery, being held in high esteem by its users. Close partnerships with user groups have been established and continually maintained, with the current offer and receipt of Bikeability being expanded upon year on year. In some respects this is due to the promotion of Bikeability by the Road Safety & Travel Awareness Team at all Road Safety events and presentations and all professional networking opportunities. For example; it is flagged up in Ad-Hoc requests for Assemblies. Parents evenings etc. It is also noted in the Transition to Secondary School Training package, which is currently delivered in all of the Boroughs Primary Schools. The uniqueness of Bikeability in Dudley is to some extent due to its established bespoke offer. There are regular 121 sessions in the Community with regular weekend, school holiday and evening provision, as well as the term time sessions. This is also due in part to its inclusivity with all schools/groups. Indeed several of Dudley's 'special schools' and even an 'Occupational Health' group regularly receive input, the latter as an aid to an ongoing improvement of the mobility of a child, who might have problems otherwise. This in itself I believe, shows a creative and innovative approach to encouraging on-going cycling post training.

- The Borough Map (Cycling routes in Dudley) This shows recommended routes, which have been identified by local cyclists and council officers, as well as off-road cycle paths, bike shops, parks and leisure facilities across the borough. It is available to download in two sections as a PDF. A paper copy is also available
- The Stourbridge Arm This map shows a section of the cycle network between Kingswinford and Stourbridge, including on-road and canal towpath alternatives. Included on the leaflet are points of interest and useful information for cyclists. It is available to download as a PDF. Paper copies are also available.
- A mini guide to cycling and walking around Dudley Produced by British Waterways in conjunction with Dudley MBC and Network West Midlands, this map describes several leisure walks and rides in the borough.
