Nearly 100 children who would not normally have participated in Bikeability training have taken part in training provided through a partnership between Hertfordshire County Council (HCC) and the Herts Disability Sports Foundation (HDSF). The children aged from 5 upwards with a range of special educational needs have participated in sessions during the last six months.

In July 2019, HCC trained four HDSF staff in Level 1 Bikeability, these four then partnered with HCC instructors to deliver training in 6 districts across Hertfordshire. By reaching out to their registered families, HDSF offered cycle training on a one to one basis or in small groups and has encouraged children with special education needs to get on a bike. Seven riders achieved Level 1, but with 28 learning to ride without stabilizers they will be coming back in the future for additional training. Many of the riders will come back for future lessons to improve their confidence.

The flexibility and ability to tailor the training whilst delivering the core values of Bikeability ensured that all abilities could take part. Several children unable to participate on two wheels, confidentially cycled on trikes at the end of the sessions.

The knowledge HCC instructors have, combined with the patience and experience of the HDSF staff has made a great delivery team.

Parents and carers have appreciated the opportunity (as seen in the testimonials attached). Places filled up quickly, with more parents/carers eager to sign up in 2020. The training was jointly funded by parents, HCC and HDSF funding sources.

This has been a fantastic partnership and we already have more sessions planned during the 2020 Easter and Summer school holidays. We hope the sessions will continue to be supported and we will be excited to see it grow and offer sessions to many more children.
