Symon made the course very enjoyable and engaged with the children from the outset, working to meet the varied needs of his students. As Cricklade was a new location for Symon he completed research before the course to ensure that he had routes and stopping points identified. This ensured that the course was location specific and gave the children as wide an experience as possible.

His organisational and administration skills are exemplary. He worked closely with the admin team to ensure that communication with parents was of a high standard, providing all of the necessary information prior to the course and completing all of the registration forms.

We are very grateful that Symon has agreed to provide Bikeability training for our pupils again next year.
